

RICHARDSON COUNTY BOARD OF COMMISSIONERS MAY 22, 2018

CALL TO ORDER

The regular meeting of the Richardson County Board of Commissioners was called to order by Chairman Sickel at 9:00 a.m. on Tuesday, May 22, 2018. Roll call was answered by Frank, Davidson and Sickel. The Invocation was given by Chairman Sickel and the Pledge of Allegiance was led by Vice-Chairman Davidson. Chairman Sickel announced that the open meeting laws have been posted at the entrance to the meeting room.

Motion was made by Davidson to approve the minutes of the May 8, 2018, meeting as presented. Motion seconded by Frank. ROLL CALL VOTE: Frank-aye, Davidson-aye, Sickel-aye. Motion carried.

Motion was made by Frank to approve the agenda as posted. Motion seconded by Sickel. ROLL CALL VOTE: Frank-aye, Davidson-aye, Sickel-aye. Motion carried. SHERIFF POUNDS

Sargent, Jeff Frederick updated the Board on the routine business within the Jail and Law Enforcement Center. The County has received a refund check from the K-9 company for the drug dog that has not been delivered, less \$1,000 for the shipping and handling.

He also reported that the county van had some mechanical problems this past week when jail staff traveled to a training. The Board decided to not put any more major repairs into this vehicle and should just be used for local, in-county travel.

ROAD & BRIDGE DEPT.

Highway Superintendent, Steve Darveau, Jr. updated the Board on the routine maintenance being done on county roads and bridges this past week.
