An incumbent is anyone serving an elective office, even if they are filing for an office other than the one in which they are presently serving they are required to file by 5:00 p.m. on the incumbent deadline.

§ 23-1701.01 Candidates for County Sheriff who do not currently have a law enforcement officer certificate of diploma issued by the Nebraska Commission on Law Enforcement and Criminal Justice shall submit with the candidate filing form required by Section 32-607 a standardized letter issued by the director of the Nebraska Law Enforcement Training Center certifying that the candidate has: a) within one calendar year prior to the deadline for filing the candidate filing form, passed a background investigation performed by the Nebraska Law Enforcement Training Center based on a check of his or her criminal history record information maintained by the Federal Bureau of Investigation through the Nebraska State Patrol. The candidate who has not passed a background investigation shall apply for the background investigation at least thirty days prior to the filing deadline for the candidate filing form; and b) received a minimum combined score on the reading comprehension and English language portions of an adult basic education examination designated by the Nebraska Law Enforcement Training Center.

§23-3202 Candidates for County Assessor must hold a Nebraska Assessor Certificate.

Receipts from the treasurer of the respective political sub-divisions for the payment of filing fees must accompany the filing form when filed in the office of Secretary of State or County Clerk before filing will be accepted. National, State and County offices require a statement of financial interest (Form C1) be filed by the candidate with the Nebraska Accountability & Disclosure Commission before the candidate's name will appear on the ballot.
