

RICHARDSON COUNTY BOARD OF COMMISSIONERS DECEMBER 8, 2020

CALL TO ORDER

The regular meeting of the Richardson County Board of Commissioners was called to order by Chairman Sickel at 9:00 a.m. on Tuesday, December 8, 2020. Roll call was answered by Frank, Caverzagie and Sickel. The Invocation was given by Chairman Sickel and the Pledge of Allegiance was led by Vice-Chairman Frank. Chairman Sickel announced that the open meeting laws have been posted at the entrance to the meeting room.

Motion was made by Caverzagie to approve the minutes of the December 1, 2020 meeting as presented. Motion seconded by Sickel. ROLL CALL VOTE: Frank-aye, Caverzagie-aye, Sickel-aye. Motion carried.

Motion was made by Sickel to approve the minutes of the December 1, 2020, Board of Equalization meeting as presented. Motion seconded by Frank. ROLL CALL VOTE: Frank-aye, Caverzagie-aye, Sickelaye. Motion carried.

Motion was made by Frank to approve the agenda as posted. Motion seconded by Sickel. ROLL CALL VOTE: Frank-aye, Caverzagie-aye, Sickel-aye. Motion carried. ROAD DEPARTMENT

Highway Superintendent, Steve Darveau, Jr. updated the Board on the routine road maintenance being done this week. He reported that crews are cutting brush on the county owned road right-of-way and working on road improvement projects in different areas in the county. Equipment repairs and possible purchases of new equipment was also discussed.

COUNTY TREASURER

Amanda Bartek-Young, County Treasurer presented to the Board pledge security receipt replacements. Motion was made by Sickel to approve the replacement of a pledge security receipt from Frontier Bank, receipt #311133576 to be replaced with receipt #421054876. Motion seconded by Frank. ROLL CALL VOTE: Frank-aye, Caverzagie-aye, Sickel-aye. Motion carried.

BRIAN KIRKENDALL, EMA DIRECTOR

Brian Kirkendall, EMA Director presented to the Board 3 informal quotes for the removal of the underground storage tank at the Courthouse. Motion was made by Sickel to approve the quote received from General Excavating in the amount of \$4,115.00 to remove the underground fuel storage tank. Motion seconded by Caverzagie. ROLL CALL VOTE: Frank-aye, Caverzagie-aye, Sickel-aye. Motion carried.

LAURA OSBORNE, 4 COUNTY JUVENILE SERVICES

Laura Osborne, informed the Board that the application for the 2021 juvenile services grant funding wouldn't be submitted until late January or February due to some changes at the NE Crime Commission with the program. She gave a report on the Juvenile Diversion program in the 4 County area and reported that Maxine Schatz the diversion instructor will be retiring at the end of June.

Additional program funding is being received from Nebraska Children and Families Foundation in the amount of \$25,000 for use from October 1, 2020 through September 30, 2021. The Neighbor To Neighbor





Program in Nemaha County is the fiscal agent for those funds.

MARK GALASKA

Mark Galaska requested to meet with the Board regarding the use of UV lights in the Courthouse for the public safety.

LAW ENFORCEMENT CENTER

Sheriff Hardesty and Chief Deputy Sheriff, Roland Merwin updated the Board on the routine business within the Law Enforcement Center this week. They reported that grant funding is expected to be awarded and received from the USDA for the purchase of 2 patrol units.

They also reviewed with the Board the anticipation of acquiring a K-9 drug dog and with that the improvements and equipment that will need to be made to a patrol unit.

A proposal was received from Motorola Solutions, Inc. for IP Consoles, Base Stations, Tower and Shelter STARCOM21. The proposal was for \$1,238,912.97.

Motion was made by Frank to adopt Resolution 2020-2021-19 to authorize and designate the number of sheriff deputies which adds an additional deputy to the amount previously set in Resolution 2019-2020-9, making the number at 8 plus a chief deputy sheriff. Motion seconded by Caverzagie. ROLL CALL VOTE: Frank-aye, Caverzagie-aye, Sickel-aye. Motion carried. (Resolution Book 25, Page 91)
