## RICHARDSON COUNTY BOARD OF COMMISSIONERS MAY 24, 2023

#### CALL TO ORDER

The regular meeting of the Richardson County Board of Commissioners was called to order by Chairman Caverzagie at 9:00 a.m. on Wednesday, May 24, 2023. Roll call was answered by Karas, Sickel and Caverzagie. The Invocation was given by Chairman Caverzagie and the Pledge of Allegiance was led by Vice-Chairman Sickel. Chairman Caverzaige announced that the open meeting laws have been posted at the entrance to the meeting room.

Motion was made by Sickel to approve the minutes of the May 17, 2023, County Board meeting as presented. Motion seconded by Karas. ROLL CALL VOTE: Karas-aye, Sickel-aye, Caverzagie-aye. Motion carried.

Motion was made by Caverzagie to approve the minutes of the May 17, 2023, Board of Equalization meeting as presented. Motion seconded by Karas. ROLL CALL VOTE: Karasaye, Sickel-aye, Caverzagie-aye. Motion carried.

Motion was made by Karas to approve the agenda as posted. Motion seconded by Sickel. ROLL CALL VOTE: Karas-aye, Sickel-aye, Caverzagie-aye. Motion carried. ### **ROAD & BRIDGE DEPT.**

Highway Superintendent, Steve Darveau, Jr. updated the Board on the routine maintenance on County roads and bridges the past few weeks. Equipment maintenance and the problem with staff shortages were some of the items that were discussed.

### LAW ENFORCMENT CENTER

Sheriff Hardesty met with the Board on the routine business within the Law Enforcement Center this week. He informed the Board that Deputy Jeff Frederick will be resigning effective June 2, 2023.

A discussion was held regarding the costs that have been incurred for the School Resource Officer for the Humboldt/Table Rock/Steinauer Public Schools and that the actual costs have exceeded the contractual amount by approximately \$7,000. Sheriff Hardesty will be meeting with the representatives from the Humboldt/Table Rock/Steinauer Public Schools to request that the school district consider approving an increase that would cover the actual costs of the school resource officer for the 2023-2024 year in the renewal agreement.

A brief discussion was also held regarding the actual costs of providing law enforcement for the City of Humboldt.

#### HOUSE OF HOPE

Jerry Yount and Sherry Huddleston representing the House of Hope requested to meet with the Board regarding the possibility of the OPIOID Settlement funds to be obligated to the organization.

The Board relayed to Mr. Yount and Mrs. Huddleston that the funds of the OPIOID Settlement are being considered for the House of Hope and that if the organization would need a letter of commitment from the County for acquiring grant funding for the start-up of the project, the County Board would at that time designate and make a future obligation of the funds to the Richardson County House of Hope.
