CALL TO ORDER

The regular meeting of the Richardson County Board of Commissioners was called to order by Chairman Caverzagie at 9:00 a.m. on Wednesday, August 23, 2023. Roll call was answered by Karas, Sickel and Caverzagie. The Invocation was given by Chairman Caverzagie and the Pledge of Allegiance was led by Commissioner Sickel. Chairman Caverzaige announced that the open meeting laws have been posted at the entrance to the meeting room.

LAW ENFORCEMENT CENTER

Sheriff Hardesty updated the Board on the routine business within the Law Enforcement Cetner this past week. The Board also reviewed further with the Sheriff the FY23-24 budget for this department with proposed changes of the County Board.

The Board received the 2022 Annual Report of the Southeast Nebraska Development District and the 2023/24 Membership Packet. Also submitted to the Board was the Annual Membership and Housing statement for dues for FY 2023-2024 in the amount of \$6,634.00.
